## IT'S TIME TO RENEW YOUR MEMBERSHIP!

It's been almost a year since I took on the role as your President; I am gratified at the progress the Association continues to make. I had the opportunity to meet some of you and heard your feedback at the AGM in November, outreach meetings through the winter and Technorama this past spring. Your voice will always be heard, I am starting to hear from more of you and we want to encourage you to continue to provide us with feedback and opinions as this helps shape the direction of the Association.

The Board has been hard at work to maintain our efficiencies; your membership fee of \$670 has been in effect since 2010/11. Due to rising costs, we will be raising the membership dues portion by 2.3% (standard cost of living increase). The 2017/18 annual membership dues will be \$541.05 (from \$528.88) plus 13% HST and the professional liability insurance of \$67 plus 8% PST, the total will be \$683.75. As a fellow professional, I understand the high fees that are associated with being a regulated health professional. The ADTO has made great strides over the past few years and it's important to understand where your professional fees are being invested.

Your Association recognizes that your involvement is important for greater success of our profession. With this in mind, we are making some changes; we will be moving our AGM to be held in conjunction with Golf Day. Fall has always been a busy season for us all and we want to see more members come out and participate in the AGM so that everyone will have an opportunity to input and understand your Association's budgeting process.
